02. In view of the exemption granted u/s.80G(5) of the IT Act, 1961
vide this office order No.Nsk/CIT-II/80G(5)/2008-09/20/14 dated 09.01.2009
for the period 01.04.2008 to 31.03.2011 by this office, I am directed to
convey that due to amendment in the Finance (No.2) Act, 2009 w.e.f.
01.10.2009, the exemption granted u/s. 80G(5)(vi) shall continue to remain in
force even after 31.03.2011 and as such there was no need to file application
for granting extension for exemption u/s.80G(5) of the IT Act, 1961.
